MoneyGram-this is a fast international money transfer system. MoneyGram company makes money transfers around the world without opening an account, combining more than 227000 customer service facilities in 190 countries of the world. This system covers the countries of the world and ranks second in the world in terms of the number of service providers. MoneyGram-this is a service for transferring money quickly and easily, always ready for service.

With MoneyGram money transfers in Uzbekistan, the following banks operate: Silk Road Bank, Kapitalbank, Khamkorbank, Invest Finance Bank, Turonbank, Qishlok Construction Bank, Hi-Tech Bank.

Since 2004, MoneyGram became the owner of Cviad Corp. and Travelers Express Company Inc. Companies are considered. Today MoneyGram is an independent company in America, and its shares are traded on the New York Stock Exchange.

In Europe, MoneyGram partners are the UK and Norwegian Royal Mail, Italian mail, Bank of Ireland, Banco Popular Espanol, Kocbank, Finansbank and many other financial institutions.

In the CIS countries, the international system of money transfers MoneyGram has been operating since 1996, and today it covers almost all the republics of Russia, Azerbaijan, Armenia, Georgia, Kazakhstan, Kyrgyzstan, Moldova, Tajikistan, Uzbekistan, Ukraine and includes more than 7000 service centers in these countries.

How to send a money transfer?

- Find the nearest MoneyGram point, focusing on the presence of a corporate logo;
- Fill out the form for sending the transfer and show your ID card;
- Pay the transfer amount together with the commission;
- You will receive the registration number of the transfer and a receipt for accepting the money;
- Inform the recipient of the registration number and in 10 minutes the money will be ready to receive.

How do I get a transfer?

- Find out the transfer number from the sender of the funds;
- Come to any point of receiving a monigram;
- Fill out the form for receiving the transfer, specifying the registration number, and show your identity card;
- get money

MoneyGram guarantees confidentiality, complete safety of money and its return in case the transfer was

not received for any reason or the sender suddenly changed plans.

The sender can return the sent money transfer, which was not received by the recipient, within an unlimited period of time, by contacting the branch of the bank that works with MoneyGram. If more than 45 days have passed since the transfer was sent, the sender must first contact MoneyGram, after which the money transfer will be restored with a new registration number and paid at any bank that works with MoneyGram.

Transfer restrictions.

Citizens of Uzbekistan can transfer foreign currency in the equivalent of no more than 5,000 US dollars in one day. This restriction does not apply to foreign citizens. When sending more than \$ 10,000 per year, the transfer data is transmitted to the tax authorities at the place of residence of the resident. Non-residents of the Republic of Uzbekistan have the right to transfer any amounts abroad, if they provide a document issued by the customs authority confirming the import of foreign currency in cash from abroad and a corresponding certificate from an authorized bank confirming the issuance of foreign currency from the account earlier.
